The ambition of the Auditorio de Tenerife is to invite everyone to participate and discover the performing arts, opera and music in the most complete and extensive way.

The aim of the auditorium is to do it in an open, transparent and durable manner, in collaboration and coordination with all cultural stakeholders of the island and region. It also promotes equal opportunities and good governance in management through the following objectives:

- 1. To promote the role of music, opera and performing arts in the individual and collective development in Tenerife, contributing equally to its national and international projection.
- 2. To identify and provide learning opportunities for the development of citizens of Tenerife through performing arts, opera and music.
- 3. To increase citizens' access to and participation in cultural life in Tenerife, fostering diversity and equal opportunities.
- 4. To promote creativity, entrepreneurship, research, lifelong learning, collaboration and professional development in the fields of music, opera and performing arts in Tenerife.
- 5. To act as an enclave that supports and reinforces the music, opera and performing arts in Tenerife. It also aims to foster the collaboration and coordination with other cultural, non-profit and commercial agents of the island and region.
- 6. To contribute to the sustainability, efficiency, environmental commitment and quality of our management.
- 7. To enhance the digital transformation of the Auditorio de Tenerife.

The management of AUDITORIO DE TENERIFE recognises its commitment to its customers through organisational criteria as a basic principle of its environmental management policy. Accordingly, it is responsible and committed to establishing and developing an environmental management system (EMS) based on the requirements of UNE ISO 14.001:2015 with the following scope: "*Planning and coordinating the execution of events. The assignment of rooms and spaces of the Auditorio de Tenerife to hold congress and cultural events. Managing and subcontracting event support services (catering, audio-visual, lighting, room staff, installation, security and cleaning)*".

Our environmental policy defines our commitment to develop our activity within the parameters of sustainability; we both control and manage the environmental impacts we might produce, especially the most significant ones. Likewise, we establish a common framework for defining objectives and conducting activities that contribute to the ongoing improvement of the environmental management system.

This EMS policy is based on the basic principles and values outlined below:



- ✓ To preserve and enhance the building as an architectural icon.
- ✓ To be the managers of a unique and multi-purpose space that allows the development of congress and commercial activities demanded by social agents, companies and institutions, offering a tailored, unique and sustainable service.
- ✓ To commit ourselves to environmental protection. We strive for ongoing improvement to prevent pollution and reduce the environmental impact of our business.
- ✓ To comply with regulatory or legal requirements to ensure the environmental protection, as well as any additional requirements defined by AUDITORIO DE TENERIFE or other interested parties.
- ✓ To carry out all the organisation's processes and tasks according to the environmental respect and sustainability principles. Likewise, to promote among its employees and collaborators a responsible environmental attitude when carrying out their activities.
- ✓ To increase the competence and awareness of the organisation's staff, involving them in the principles of this Policy, and training them to become aware on how important it is to carry out their work and actions in an ethical, ecological and responsible manner.
- ✓ To integrate the EMS to the global management system of Auditorio de Tenerife.
- ✓ To carry out an annual evaluation of those environmental aspects derived from our activity for an ongoing maintenance and improvement of the EMS.
- ✓ To collaborate with authorities and other environment-related stakeholders to preserve and improve our environment.

Each year, AUDITORIO DE TENERIFE formulates environmental objectives and targets. They are based on an ongoing analysis of the activity's risks and knowledge of the external and internal context where it operates. The objectives will always be measurable and consistent with this Policy and principles set out in it. It also monitors and verifies the compliance with them. To do so, it checks the progress made, adapts the objectives and targets to the origin and magnitude of the environmental impacts caused by our activity and products throughout their life cycle.

All AUDITORIO DE TENERIFE employees are obliged to know and apply the principles defined in this Environmental Policy both to carry out their working tasks, and their tasks with clients, suppliers or other stakeholders. AUDITORIO DE TENERIFE'S EMS Policy is available to all interested parties through the organisation's website.
